The purpose of this Request for Proposal (RFP) is to solicit proposals to establish a contract or contracts through competitive negotiations for Writing and Editorial Services by Virginia Polytechnic Institute and State University (Virginia Tech), an agency of the Commonwealth of Virginia.

Virginia Tech's colleges and units are often in need of Writing and Editorial services to meet communications objectives on a variety of platforms. To extend its resources, Virginia Tech seeks vendors to enter into a general contract to provide high-quality services to Virginia Tech entities on an as-needed basis.

#### II. SMALL, WOMAN-OWNED AND MINORITY (SWAM) BUSINESS PARTICIPATION:

It is the intent of this solicitation and resulting contract to allow for cooperative procurement. Participation in this cooperative procurement is strictly voluntary. Participating entities shall place their own orders directly with the Contractor and shall fully and independently administer their use of the contract to include contractual disputes, invoicing and payments without direct administration from Virginia Tech. Virginia Tech shall not be held liable for any costs or damages incurred by any other participating entity as a result of any authorization by the Contractor to extend the contract. It is understood and agreed that Virginia Tech is not responsible for the acts or omissions of any entity, and will not be considered in default of the contract no matter the circumstances.

Use of this contract does not preclude any participating entity from using other contracts or competitive processes as the need may be.

## VI. STATEMENT OF NEEDS/SCOPE OF WORK:

A. The contractor shall provide all labor, materials, tools, equipment and supervision needed to provide writing and/or editorial services for various Virginia Tech projects and shall render one or more of the following services for any given project.

  - a. Describe your ability to create original content or edit for use on the web, in emails, or on various social media platforms.
  - b. Describe your ability to provide/experience with creating simple visuals such as photos or simple graphics to enhance engagement with text on digital platforms.
  - c. Describe your ability to copyedit and edit materials in order to improve content, comply with AP style and university style for digital platforms, and meet client objectives.
- B. Provide a list of the equipment your firm will use to service the requirements of the contract to include computer platform, iOS or Android, word processing software, and any other equipment specific to the assignment.
- C. Describe your ability to adhere to required deadlines, to include how materials will be shared, i.e. will all communications be electronic, or will your firm be available for on-site updates/meetings.
- D. Describe your availability for short-turnaround rush projects and/or projects that may require your involvement over a longer period of time.
- E. Describe your ability to comply with and meet the following requirement: Contractor shall abide by Virginia Tech brand guidelines and follow directions from university staff. Contractor shall agree all submissions will be factually accurate, original, not previously published, nor infringe any copyright or trademark rights and that Virginia Tech will own all right, title and interest and all publication and archival rights to all submitted work in all languages for use on the website, in publications, or in any present of future medium. Describe your company's plan to take care of any/all copyright procurement and confirm that all content shall be owned by the university and shall retain all rights associated with the completed material.

## VII. PROPOSAL PREPARATION AND SUBMISSION:

#### A. Specific Requirements

- 4. Provide completed samples of your work to serve as examples of the quality of services that your company can provide and so VT can ascertain their suitability for the intended purpose.

#### B. General Requirements

- 1. RFP Response: In order to be considered for selection, Offerors shall submit a complete response to this RFP to include;
  - a. **One (1) electronic document** in WORD format or searchable PDF of the entire proposal <u>as one document</u>, INCLUDING ALL ATTACHMENTS must be uploaded through the Bonfire online submission portal. Refer to page 2 for instructions.

Any proprietary information should be clearly marked in accordance with 2.d. below.

b. Should the proposal contain proprietary information, provide one (1) redacted electronic copy of the proposal and attachments with proprietary portions removed or blacked out. This redacted copy should follow the same upload procedures as described on Page 1 of this RFP. This redacted copy should be clearly marked *"Redacted Copy"* within the name of the document. The classification of an entire proposal document, line item prices and/or total proposal prices as proprietary or trade secrets is not acceptable. Virginia Tech shall not be responsible for the Contractor's failure to exclude proprietary information from this redacted copy.

No other distribution of the proposals shall be made by the Offeror.

- 2. Proposal Preparation:
  - a. Proposals shall be signed by an authorized representative of the Offeror. All information requested should be submitted. Failure to submit all information requested may result in Virginia Tech requiring prompt submission of missing information and/or giving a lowered evaluation of the proposal. Proposals which are substantially incomplete or lack key information may be rejected by Virginia Tech at its discretion. Mandatory requirements are those required by law or regulation or are such that they cannot be waived and are not subject to negotiation.
  - b. Proposals should be prepared simply and economically providing a straightforward, concise description of capabilities to satisfy the requirements of the RFP. Emphasis should be on completeness and clarity of content.
  - c. Proposals should be organized in the order in which the requirements are presented in the RFP. All pages of the proposal should be numbered. Each paragraph in the proposal should reference the paragraph number of the corresponding section of the RFP. It is also helpful to cite the paragraph number, subletter, and repeat the text of the requirement as it appears in the RFP. If a response covers more than one page, the paragraph number and subletter should be repeated at the top of the next page. The proposal should contain a table of contents which cross references the RFP requirements. Information which the offeror desires to present that does not fall within any of the requirements of the RFP should be inserted at an appropriate place or be attached at the end of the proposal and designated as additional material. Proposals that are not organized in this manner risk elimination from consideration if the evaluators are unable to find where the RFP requirements are specifically addressed.
  - d. Ownership of all data, material and documentation originated and prepared for Virginia Tech pursuant to the RFP shall belong exclusively to Virginia Tech and be subject to public inspection in accordance with the Virginia Freedom of Information Act. Trade

secrets or proprietary information submitted by an Offeror shall not be subject to public disclosure under the Virginia Freedom of Information Act. However, to prevent disclosure the Offeror must invoke the protections of Section 2.2-4342F of the Code of Virginia, in writing, either before or at the time the data or other materials is submitted. The written request must specifically identify the data or other materials to be protected and state the reasons why protection is necessary. –The proprietary or trade secret material submitted must be identified by some distinct method such as highlighting or underlining and must indicate only the specific words, figures, or paragraphs that constitute trade secret or proprietary information. The classification of an entire proposal document, line item prices and/or total proposal prices as proprietary or trade secrets is not acceptable and may result in rejection of the proposal.

3. Oral Presentation: Offerors who submit a proposal in response to this RFP may be required to give an oral presentation of their proposal to Virginia Tech.—This will provide an opportunity for the Offeror to clarify or elaborate on the proposal but will in no way change the original proposal. Virginia Tech will schedule the time and location of these presentations. Oral presentations are an option of Virginia Tech and may not be conducted. Therefore, proposals should be complete.

#### VIII. SELECTION CRITERIA AND AWARD:

## B. Award

Selection shall be made of two or more offerors deemed to be fully qualified and best suited among those submitting proposals on the basis of the evaluation factors included in the Request for Proposal, including price, if so stated in the Request for Proposal. Negotiations shall then be conducted with the offerors so selected. Price shall be considered, but need not be the sole determining factor. After negotiations have been conducted with each offeror so selected, Virginia Tech shall select the offeror which, in its opinion, has made the best proposal, and shall award the contract to that offeror. Virginia Tech may cancel this Request for Proposal or reject proposals at any time prior to an award. Should Virginia Tech determine in writing and in its sole discretion that only one offeror has made the best proposal, a contract may be negotiated

and awarded to that offeror. The award document will be a contract incorporating by reference all the requirements, terms and conditions of this solicitation and the Contractor's proposal as negotiated.

Virginia Tech reserves the right to award multiple contracts as a result of this solicitation.

Informal communications, including but not limited to request for information, comments or speculations regarding this solicitation to any University employee other than a Procurement Department representative may result in the offending Offeror's proposal being rejected.

#### XIII. CONTROLLING VERSION OF SOLICITATION:

The posted version of the solicitation and any addenda issued by Virginia Tech Procurement Services is the mandatory controlling version of the document. Any modification of/or additions to the solicitation by the Offeror shall not modify the official version of the solicitation issued by Virginia Tech Procurement Services. Such modifications or additions to the solicitation by the Offeror may be cause for rejection of the proposal; however, Virginia Tech reserves the right to decide, on a case by case basis, in its sole discretion, whether to reject such a proposal.

## XIV. TERMS AND CONDITIONS:

This solicitation and any resulting contract/purchase order shall be governed by the attached terms and conditions, see Attachment A.

#### XV. CONTRACT ADMINISTRATION:

- A. The individual user departments at Virginia Tech shall be identified as the Contract Administrators and shall use all powers under the contract to enforce its faithful performance.
- B. The Contract Administrators in each user departments shall determine the amount, quantity, acceptability, fitness of all aspects of the services and shall decide all other questions in connection with the services. Contract Administrators, or designees, shall not have authority to approve changes in the services which alter the concept or which call for an extension of time for this contract. Any modifications made must be authorized by the Virginia Tech Procurement Department through a written amendment to the contract.

## ADDITIONAL TERMS AND CONDITIONS

- ADDITIONAL GOODS AND SERVICES: The University may acquire other goods or services that the supplier provides other than those specifically solicited. The University reserves the right, subject to mutual agreement, for the Contractor to provide additional goods and/or services under the same pricing, terms and conditions and to make modifications or enhancements to the existing goods and services. - 2. AUDIT: The Contractor hereby agrees to retain all books, records, and other documents relative to this contract for five (5) years after final payment, or until audited by the Commonwealth of Virginia, whichever is sooner. Virginia Tech, its authorized agents, and/or the State auditors shall have full access and the right to examine any of said materials during said period.
- **3. AVAILABILITY OF FUNDS**: It is understood and agreed between the parties herein that Virginia Tech shall be bound hereunder only to the extent of the funds available or which may hereafter become available for the purpose of this agreement.
- 4. CANCELLATION OF CONTRACT: Virginia Tech reserves the right to cancel and terminate any resulting contract, in part or in whole, without penalty, upon 60 days written notice to the Contractor. In the event the initial contract period is for more than 12 months, the resulting contract may be terminated by either party, without penalty, after the initial 12 months of the contract period upon 60 days written notice to the other party. Any contract cancellation notice shall not relieve the Contractor of the obligation to deliver and/or perform on all outstanding orders issued prior to the effective date of cancellation.
- 5. CONTRACT DOCUMENTS: The contract entered into by the parties shall consist of the Request for Proposal including all modifications thereof, the proposal submitted by the Contractor, the written results of negotiations, the Commonwealth Standard Contract Form, all of which shall be referred to collectively as the Contract Documents.

As a recently retired communications specialist from North Carolina State University and longtime freelancer for other colleges and universities, I've had a hand in just about everything that can be written or edited on a university campus, aside from scientific articles for peer-reviewed journals. I've written and edited <u>news briefs</u>, <u>in-depth features</u>, and <u>people profiles</u> for newsletters, magazines, annual reports, and websites; scripts for <u>podcasts</u> and <u>videos</u>; speeches and letters for college deans and other administrators; activity and impact reports for federal and state agencies and lawmakers; <u>news releases</u> and explainers on timely issues of public concern; collateral material for marketing and fundraising; and how-to manuals and educational guides for extension clientele.

b. I have a knack for listening, getting answers and respecting people's passions and wisdom.

Like Virginia Tech, NC State is a research-intensive, land-grant university. These institutions serve people from all walks of life, so it's important that they speak in ways that make sense and resonate with all.

At NC State, I built on the skills I'd gained interviewing, doing background research and writing for local newspapers. To report on government, politics, religion, education, crime, lifestyles and more, I met and interviewed school students, school board members, engineers, entrepreneurs, housekeepers, homebuilders, shoppers and shop owners – the entire range of people living and working in Southeast North Carolina.

At the university, my sources – <u>students, researchers</u>, <u>instructors</u>, <u>extension educators</u>, <u>advisers</u>, <u>alumni</u>, <u>farmers</u>, <u>farm leaders</u>, and <u>other stakeholders</u> – were different, the topics frequently more complex and the audience much larger – global, in fact. I spent most of my time in the College of Agriculture and Life Sciences, but I also worked for NC State's alumni association and its news services office. That gave me the chance to write stories with sources from a wide range of colleges and departments.

I love covering science, technology and its intersection with real life because I'm passionate about people and believe that we will survive and thrive only if we continue to invest in research, teaching and extension education that makes our world better economically, environmentally and socially.

c. I have the ability to convey complex stories and information in engaging, understandable ways.

I take pride in writing about complex subjects in ways that allow readers with differing backgrounds to understand and engage with the content. Through experience, formal education and active engagement in professional development, I know a lot about the English language and about ways to share stories and knowledge, especially in writing. I'm not a scientist or engineer, but I enjoy learning from experts about their knowledge and discoveries and then working closely with them to translate what they have to say into language that readers can understand.

I'll let my national award-winning story <u>Talking the (Plant) Talk</u> do the talking for me. I wrote it for a magazine that goes to alumni and other college stakeholders. As research and development progressed, I later developed a news release (<u>Unearthing Plant Problems – Using Sensors</u>) as part of an initiative to make NC State a world leader in plant sciences research and innovation.

d, e. I know AP and university style and how to use them, maintain the writer's voice, reflect the institutional brand and meet the needs of clients, writers and readers.

I'm proficient in writing according to AP style and editing the work of others so that it follows that style. Thanks to my recent freelance work editing educational publications for Virginia Cooperative Extension, I've become versed in your university's style and brand.

My goal as editor is to be an advocate for the reader while a knowledgeable resource for the writer. I suggest changes in wording and punctuation when I detect a conflict between the writer's choices and the institution's style or brand books. When it comes to conveying information, consistency isn't the hobgoblin of small minds. It's a powerful tool for keeping the reader engaged and learning, rather than distracted or questioning an author's credibility. If I think a writer might have questions about why I made a change, I leave a note of explanation. If I don't understand what the writer is trying to say or think the wording might be confusing or inaccurate, I ask for clarification.

I value both the reader and the writer, and my job as editor is to be a go-between, ensuring that, when the story's told or the publication's complete, both get what they want and need.

#### How I'll Go About My Work

- B. I use a MacBook Air (iOS) computer with Microsoft Word and, if needed, Adobe Creative Cloud software such as InDesign, Photoshop and Acrobat Pro. I'm also a fan of Google Docs and use it frequently.
- C. I work with project managers to determine their preferred method of sharing materials and communicating about the project. While I don't live in Virginia, I'm reachable by telephone and email and can communicate via Zoom and other teleconferencing tools, making the need for in-person, on-campus meetings unnecessary. Still, I'm willing to travel when that's what it takes to get the job done.

I have a strong track record for keeping projects on time and within budget. I work with clients to establish milestones before a project begins, and when something unexpected causes delays on the clients' end, I still make every effort to keep the project on track. If other obligations make that impossible, I'll let the client know so that we can discuss other options. And on the rare occasion when I run into problems that keep me from meeting a deadline, I let the client know as soon as possible so we can resolve them.

- D. Because I am determined to deliver high-quality work but am usually juggling multiple obligations, short turnaround jobs aren't my strong suit. However, I am happy to take on long-term projects.
- E. 

## **Negotiation Questions**

1. Virginia Tech Question: What is your process for managing deadlines if/when a project's parameters change after work has been initiated?

Deirdre Dawn M Shore answer- Because I keep a limited client base, I have never encountered a situation when I could not meet a client's deadline. If a project's parameters change, I talk to my clients as soon as possible to determine if the change would affect my ability to meet a previously established deadline. If so, I work with the client to revise the production schedule. However, if I believed that I adjusting to the changed parameters would sacrifice project quality, I would discuss that with the client before attempting the work. If meeting the previously agreed upon deadline would jeopardize my ability to meet prior commitments and the client could not agree to a revised production schedule, I would work encourage the client to consider options, such as my subcontracting the work or to seek another vendor.

2. Virginia Tech Question: Once a project is at the approval stage, if significant changes become necessary how do you manage your schedule to ensure final deadlines are met?

Deirdre Dawn M Shore answer- This hasn't happened in my work as a contractor, but I've encountered such situations in my career – usually when something happened that neither I nor my employer expected. In these cases, I reworked my schedule, pushing out lower-priority projects or those with later deadlines, or worked overtime. Although I will not charge an "overtime" rate for contracted work, I would work as hard as I could for as long as I could to address needed changes in time to meet the final deadline.

3. Virginia Tech Question: What is your communication process if a final deadline becomes difficult to meet?

Deirdre Dawn M Shore answer- If a final deadline would be difficult to meet, I would make every effort to communicate with the client as soon as possible to let them know that. I say "make every effort" because I can imagine unlikely situations, such as natural disaster or sudden severe illness or injury, when communicating would be impossible. Fortunately, it's been my experience that such situations are extremely rare.

4. Virginia Tech Question: As part of Virginia Tech standard procedures, all awarded contracts will be publicly posted on an online contracts portal. Is there any information included that would be used to identify or harm a person's identity, finances or personal information? If so, please provide a redacted copy of your proposal.

Deirdre Dawn M Shore answer- I am concerned about having my references' contact information online, so I am attaching a copy with that information redacted.

5. Virginia Tech Question: Are there any additional financial or value-added incentives you would like to offer at this time? (i.e. signing bonus, scholarships, academic or athletic program support, etc.?)

Deirdre Dawn M Shore answer- No.

6. Virginia Tech Question: Are there any additional forms or documents that you will require to be incorporated into the contract documents? If so, please submit.

Deirdre Dawn M Shore answer- No.

7. Virginia Tech Question: Does your company agree to provide monthly invoices with payment due thirty (30) days after receipt of invoice or goods/services, whichever is later?

Deirdre Dawn M Shore answer- Yes.

8. Virginia Tech Question: Do you agree that you will be performing services as an Independent Contractor, Company, Corporation or other business entity and are not an employee of Virginia Tech or any other Commonwealth Entity?

Deirdre Dawn M Shore answer- Yes.

9. Virginia Tech Question: Do you further agree that Virginia Tech will not withhold any income taxes from its payments to contractors nor will it provide any employment benefits to the contractor or contractor's employees?

Deirdre Dawn M Shore answer- Yes.

10. Virginia Tech Question: End of Contract Service Transition Expectations: If or when a transition of service to another provider is required (end of contract life or otherwise), the university would require the incumbent firm to cooperative fully in a successful transition of services. Explain any requirements your firm might have in preparing for such a transition of services. Additionally, please indicate your willingness to establish a transition plan alongside the new provider of service which may include but not be limited to sharing important data and/or existing service information via a cooperative knowledge transfer process.

Deirdre Dawn M Shore answer- Upon the request of Virginia Tech, I am willing to work establish a transition plan alongside the new service provider, providing important data and existing service information via a cooperative knowledge transfer process. I would require Virginia Tech to specify the information and data to be transferred and to let me know the expectations for how and when to deliver the information and data. I will make the transfer as soon as possible but request at least 2 weeks, unless the transfer is simple or due to unexpected or unavoidable circumstances.

11. Virginia Tech Question: Do you agree that the initial contract period shall be three (3) years?

Deirdre Dawn M Shore answer- Yes.

12. Virginia Tech Question: Upon completion of the initial contract period, does your company agree that the contract may be renewed by Virginia Tech upon written agreement of both parties for two (2) three-year periods, under the terms of the current contact?

Deirdre Dawn M Shore answer- Yes.

13. Virginia Tech Question: If awarded a contract, are you willing to hold prices firm for the initial contract period?

Deirdre Dawn M Shore answer- Yes.

14. Virginia Tech Question: While other factors such as the methodology, quality of service and prior experience are considered during the selection process, the evaluation of price, including the annual maintenance fee, is a key element of the evaluation. With this in mind, please provide your company's most competitive price structure.

Deirdre Dawn M Shore answer- Writing services under this contract would be provided at \$55 per hour and copyediting at \$50 per hour.

15. Virginia Tech Question: Will your company agree to participate in the Wells One AP Control Payment System?

Deirdre Dawn M Shore answer- No.

16. Virginia Tech Question: Please describe your quickest turn-around time if emergency services are needed.

Deirdre Dawn M Shore answer- Because I am determined to deliver high-quality work but usually have multiple obligations, short turnaround jobs aren't my strong suit. However, if emergency services are needed, I will make every effort to meet those needs so long as doing so will not jeopardize the quality of the work or my ability to meet prior commitments.

17. Virginia Tech Question: Are you willing to contact departments on a monthly basis to address service issues?

Deirdre Dawn M Shore answer- Yes.

18. Virginia Tech Question: Will you be able to handle increased volumes of business and/or provide service to additional departments during the course of the contract?

Deirdre Dawn M Shore answer- Yes, this would be possible, but as a one-person operation, my capacity is limited. I cannot take on work if would interfere with meeting clients' deadlines and quality expectations for editing or writing that I've previously committed to.

19. Virginia Tech Question: How soon after contract award can you begin providing services?

Deirdre Dawn M Shore answer- Immediately.

20. Virginia Tech Question: Are you registered with and willing to participate in the eVA internet procurement solution described in the terms and conditions of the RFP?

Deirdre Dawn M Shore answer- Yes.

21. Virginia Tech Question: Do you acknowledge, agree and understand that Virginia Tech cannot guarantee a minimum amount of business if a contract is awarded to your company?

Deirdre Dawn M Shore answer- Yes.

22. Virginia Tech Question: Are the prices for all goods/services listed in your proposal inclusive of all applicable eVA system transaction fees?

Deirdre Dawn M Shore answer- Yes.

23. Virginia Tech Question: Does the vendor acknowledge, agree, and understand that the terms and conditions of the RFP # 5671412202 shall govern the contract if a contract is awarded to your company?

Deirdre Dawn M Shore answer- Yes.

24. Virginia Tech Question: Do you agree to become a certified SWaM vendor with the Virginia Department of Small Business and Supplier Diversity and maintain that certification throughout the term of this contract?

Deirdre Dawn M Shore answer- Yes. I do have a question about the certification process: Is there any way to register without a business license? I tried to register, but the system asked for a business license. I would like not to incur this expense if it is not necessary, and I do not believe it is necessary because I live and work in the City of Raleigh, North Carolina, which does not require a license for businesses operating within the city, and I understand from the Town of Blacksburg that it does not require a business license if my gross receipts from Virginia Tech are less than \$25,000 in a calendar year, which I do not expect they will be. (I have no other clients in Blacksburg.)

25. Virginia Tech Question: If awarded a contract, do you agree to limit price increases to no more than the increase in the Consumer Price Index, CPI-W, All Items category for the latest twelve (12) months for which statistics are available at the time of renewal or 3 percent, whichever is less?

Deirdre Dawn M Shore answer- Yes.
