Hard Drives - Wipe It Before Sending to Surplus Property

It is the responsibility of university departments to assure all computer hard drives are free of all data and software <u>before</u> they are transferred outside of the department. Before sending to Surplus Property any components that contain a hard drive, be sure the data is completely wiped as a precaution. A final data cleanse and inspection of the equipment will happen in Surplus Property by trained IT staff before any equipment is sold or destroyed through the surplus process.

New Fast Track Team!

To better serve the campus, Procurement has created a fast track processing team that specifically handles requisitions under \$10,000. We are continuously working to improve the turn-around time for getting orders processed to vendors.

If you need an order processed faster, when submitting a requisition that is between two-thousand (\$2,000) and ten-thousand (\$10,000) dollars, attach a matching quote to your requisition. That will help speed up the processing.

Please be sure to enter a "contact name" in the shipping information on purchase requisitions in HokieMart. Many vendors will not ship to Virginia Tech (such as Dell) if a contact name is not part of the shipping instructions.
